In view of the exercise by the Federal Property Management Agency in accordance with the Federal Law № 208-FZ "On Joint Stock Companies" dated 26.12.1995, Regulation on the control of the federally owned shares of joint stock companies and drawing on special right of the Russian Federation to control joint stock companies ("Golden share"), approved by the resolution of the Government of the Russian Federation № 738 dated 03.12.2004, and Regulation on the Federal Property Management Agency, approved by the resolution of the Government of the Russian Federation dated 05.06.2008 № 432 "On the Federal Property Management Agency", of authority of the general shareholders meeting of Joint stock company Russian Agricultural Bank (hereafter – JSC Rosselkhozbank), whose 100% of ordinary shares is the property of the Russian Federation, with reference to directives of the Government of the Russian Federation dated 11.02.2017 № 965p-P13:
